DATABASES INCLUDED IN THE PACKAGE

HeinOnline's Australia / New Zealand Core package is designed to provide a base of content to meet your research needs. HeinOnline's databases are dedicated to treaties, constitutions, case law, world trials, classic treatises, international trade, foreign relations, and much more.

Acts of the Parliament of the Commonwealth of Australia

The Acts of the Parliament of the Commonwealth of Australia are published annually, and each year's set consists of several volumes. Each set contains the full text of all acts assented to by the Australian parliament within a given year, as well as tables containing alphabetical and numerical lists of the acts.

Australian Law Reform Commission (ACRL)

The Australian Law Reform Commission database in HeinOnline consists of hundreds of documents related to Civil Procedure, Discrimination, Intellectual Property, National Security, Traditional Rights, and more.

Canada Supreme Court Reports

HeinOnline's Canada Supreme Court Reports contains the official, bilingual series published under authority of the Supreme Court Act. This database includes more than 10,000 cases which include background information, statutes and regulations, authors cited, analysis and the decisions.

Civil Rights and Social Justice

This database brings together a diverse offering of publications covering civil rights in the United States as their legal protections and definitions are expanded to cover more and more Americans.

Code of Federal Regulations

The Code of Federal Regulations (CFR) is the codification of the general and permanent rules and regulations (sometimes called administrative law) published in the Federal Register by the executive departments and agencies of the federal government of the United States.

CourtListener (U.S. State & Federal Case Law)

Explore a vast collection of U.S. state & federal case law through HeinOnline's integration with CourtListener. Case law may be accessed seamlessly via citation lookup or inline hyperlinking within documents that cite the case. Coverage includes 99% of all precedential legal case law published in the United States.

COVID-19: Pandemics Past and Present

This database contains publications on the various ways COVID-19 has impacted every aspect of life, from testing issues in the medical field to unemployment and economic impact. This database, much like our understanding of COVID-19, will continue to evolve as new content is published and integrated with regular updates. Importantly, this collection also features subcollections dedicated to Past Pandemics, and Vaccinations.

Criminal Justice & Criminology

This collection offers an historical overview of how criminal justice has changed in American and English law and the effect criminology has had in facilitating those changes. It collects government documents as well as rare or hard to find pamphlets, memoirs, and books written by ordinary law enforcement officers and not-so-famous criminals.

Early American Case Law

Contains the entire *Federal Cases* 30 book series (1894-1897) which contains more than 20,000 cases. Also included is the Trinity Series, which includes American Decisions, American Reports, and American State Reports.

English Reports

HeinOnline's English Reports database delivers exact page images of the original bound reprint edition of *The English Reports*, along with the *Statutes of the Realm* (1235-1713), and pre-1865 law reports for England and Wales.

European Centre for Minority Issues (ECMI)

The ECMI conducts practice-oriented research, provides information and documentation, and offers advisory services concerning minority-majority relations in Europe. This database contains several publications of the ECMI, including ECMI Reports and Working Papers.

Federal Register Library

The Federal Register is the official journal of the federal government of the United States that contains government agency rules, proposed rules, and public notices. HeinOnline's coverage dates back to inception in 1936.

Foreign Relations of the United States (FRUS)

The FRUS series presents the official documentary historical record of major U.S. foreign policy decisions and significant diplomatic activity. It is comprised of hundreds of books beginning with Abraham Lincoln's administration in 1861 and continuing to the administration of Ronald Reagan in 1988.

Gun Regulation and Legislation in America

This database brings together essential periodicals, compiled legislative histories, CRS reports, Congressional hearings, United States Supreme Court briefs, monographs, and other related materials on the difficult and controversial topic of regulating firearms in the United States.

Law Academy Project

Discover the history of legal education in America through the works of the Law Academy, one of the earliest educational institutions in the United States for law-related education, established in 1821 in Philadelphia, PA. This database gathers the Academy's pamphlets and pairs them with biographical highlights of the author and a summary of its contents

Law Journal Library

Contains more than 3,300 multidisciplinary periodicals. Subjects covered include criminal justice, political science, technology, human rights, and more. Coverage for all journals is from inception and goes through the most currently published issues allowed based on contracts with publishers.

Law Library of Congress Reports

More than 3,500 reports from the Law Library of Congress on foreign, comparative, and international law—all in one easy-to-navigate collection.

Legal Classics

Includes nearly 20,000 titles from some of the greatest legal minds in history including Joseph Story, Jeremy Bentham, William Blackstone, William Holdsworth, Henry Maine, Frederick William Maitland, Frederick Pollock, Benjamin N. Cardozo, and many more! In addition to many classic treatises, this database also includes rare items that are found in only a handful of libraries around the world.

Legal Dictionaries

This impressive database of legal dictionaries is composed of more than 300 titles from various countries, on multiple topics. Browse content by title or country. Key titles include the Compendius Dictionary of the English Language, several Concise Law Dictionaries, and more.

LexBlog Library
